



TENNIS COURT RESTORATION FUNDRAISER



In conjunction with the Amador Tennis Club, the Argonaut High School Tennis Team plans to turn wins into dollars this season. For every set the team wins, you can pledge your support for the team and the courts. The goal for ATC is to raise \$20,000 from the community to repair the cracks and resurface the courts. Your pledge of support for the Argonaut Tennis Team is *tax deductible* and a great way to build a strong tennis program for our kids.

The Argonaut Tennis Team format includes one Boys and Girls singles match, two Boys and Girls doubles matches and one mixed doubles match for a total of seven. Each match within the match is a best of three set format, so a total of 14 sets are possible each match. Excluding the 4 tournaments and CIF San Joaquin Section playoffs, there are a minimum of 266 sets that the team will play. Pledges are based on team sets won.

You can either pledge a per set amount or a flat rate for the entire season, but "per set" pledges are encouraged to show your support for a successful Mustang Tennis season! Coach O'Loan will certify the number of sets after the playoffs have concluded and you will then be contacted and asked to contribute your pledge total.
